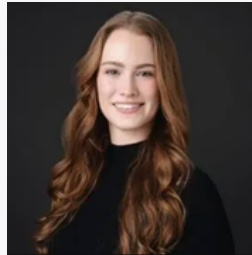

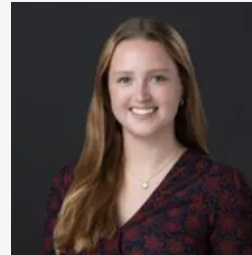

260

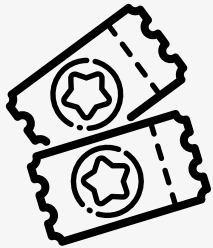
In 2025, ELMCC grew to 260 members, with businesses from Shorewood to Minnetonka and the surrounding areas.

95%

Events

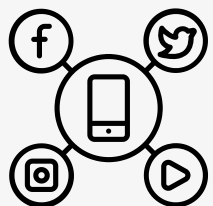


The Chamber hosted 52 events in 2025. 13 of these were large-scale community events, resulting in almost 50,000 counted attendees and an over 4 million dollar economic impact on the community.

Website and Social Media



In Q4 of 2025 alone, elmcc.org had over 47k website views, 2.8k member directory views, and 7.5k event calendar views.



As of January 2026, the Chamber has over 16k social media followers. In 2025, our Facebook and Instagram hit a collective 1.3m views; our click rate grew by 30%, our interactions by 100%, and our total reach by 80%.

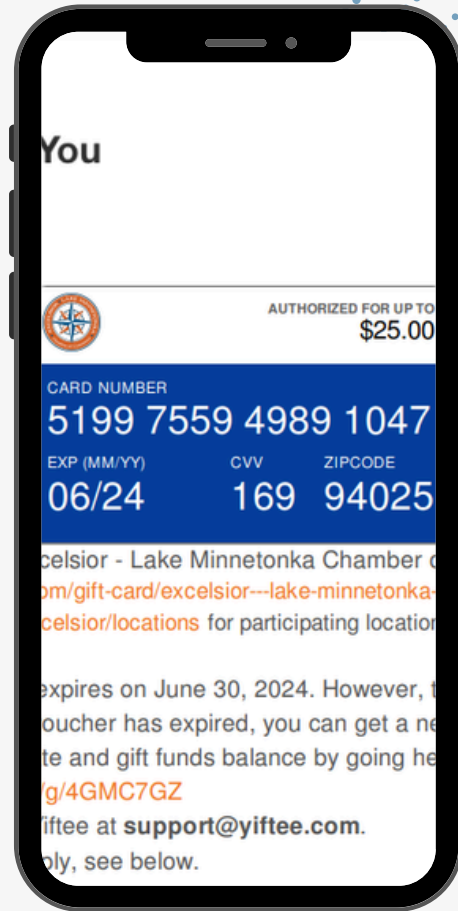


